## **Public Open Spaces**

NAGAR continued to urge the MCGM to follow Best Practices for maintaining all Public Open Spaces owned by them. To emphasize the importance of this, NAGAR chose W.I.T. ground, a neglected public open space designated as a playground, located in Mahim. NAGAR has prepared the design to restore the character of the playground to showcase an ideal plan and will share this with MCGM for implementation.

NAGAR strongly objected to MCGM's interim policy on public open spaces, that was passed hurriedly before the end of the tenure of the then elected body and days before the restrictions imposed under the election code of conduct. The Policy facilitated an unacceptable option to private organisations, NGOs and citizen groups to enable them to retain their hold over the 216 public open spaces that were to be taken back from them under the orders of the Chief Minister Mr. Devendra Fadnavis.





NAGAR wrote a letter to the Chief Minister, Mr. Devendra Fadnavis objecting to the construction of a 'Theme Park' on the Mahalaxmi racecourse land. NAGAR pointed out the dismal ratio of public open spaces in Greater Mumbai – 1.09m per person - and highlighted the fact that the racecourse is one of the few large open spaces which serve as a green lung as well as a natural sponge during the monsoons for the Island city. In addition, it is Grade II-B heritage structure as per the heritage list appended to the Heritage Regulations for Greater Bombay, 1995.

### Revised Draft Development Plan 2014-2034

NAGAR actively responded to the Revised Draft Development Plan (RDDP) (2014 – 2034) by submitting its suggestions & objections from time-to-time. It also encouraged fellow citizen groups to give well-thought responses for the betterment of the city. A special social media link was created and added to the NAGAR website for this purpose.

NAGAR wrote to Mr. R. Balachandran, the Chief Engineer (DP) highlighting the flaws in the RDDP 2034. Ms. Nayana Kathpalia and Ms. Meher Rafaat (both Trustees) met Mr. Ramanath Jha to give NAGAR's inputs for the Revision of the Development Plan (2014 - 2034). An article in Mumbai Mirror, dated April 18, 2017, entitled 'BMC offers builders squat & grab chance to usurp open spaces' quotes NAGAR stating, "Mumbai has approximately 1400 reserved public open spaces, according to a survey conducted by NAGAR, an NGO fighting for protection of open spaces. All of these could become vulnerable to encroachment and then commercial exploitation if the new provision in the Development plan goes through."

Further to the publication of NAGAR's book entitled "Forts of Mumbai – Abandoned Treasures", a project for rejuvenation of Forts was taken up. For this project NAGAR began working closely with the relevant government authorities namely the Director, the Directorate of Archaeology & Museums (Government of Maharashtra) and the Superintending Archaeologist, Mumbai Circle, Archaeological Survey of India for discussion regarding the respective forts under their jurisdiction. As a part of the endeavour, NAGAR is preparing a report, in consultation with a conservation architect.

As a first step towards conservation of water bodies, NAGAR began compiling information on the status of the existing water bodies in Greater Mumbai using the effective tool of RTI.

As of now, NAGAR has been provided with the list of water bodies existing in all the 24 wards of Greater Mumbai. On further study, it was found that some of the wards do not have adequate information, some have just a list for their record and some have included even drains as water bodies. NAGAR has decided to prepare a status report of the present condition of water bodies and also provide recommendations for their conservation. Inputs from experts, dialogue with the officials and citizen groups will be part of this exercise.


## **Solid Waste Management**

NAGAR drafted an Integrated Solid Waste Management Policy for Greater Mumbai 2016 – 2021 and presented it to Mr. Ajoy Mehta, the Municipal Commissioner, MCGM. This policy was drafted to constructively resolve the complex issue

of managing solid waste for a burgeoning metropolis like Greater Mumbai. The policy was based on hands-on experience,

observations and analysis of various reports.

Currently the policies drafted by MCGM are hugely inadequate and the dumping grounds are reaching crisis levels. At times, the dumping grounds catch fire leading to an outbreak of respiratory diseases. Considering this urgent need, NAGAR drafted this policy to enable a partnership between the people and the MCGM to treat waste in an efficient and scientific manner.

## **Meetings and Networking**

NAGAR is deeply concerned on the issue of development of Mumbai's Portland. NAGAR believes that a Master Plan is essential for the entire Eastern Water Front (EWF) and that this area should be integrated with the Development Plan of Greater Mumbai 2014-2034. The focus of such a plan should be on recreation and leisure for the citizens where at least 50-60% of this land should be reserved as public open space. Tree plantation on a large scale must be undertaken to increase the green cover on the rather barren MbPT land and no private housing should be permitted.

After a careful study of MCGM's Comprehensive Mobility Plan 2016, NAGAR held a focus group meeting on Road Space Management with some experts in the field. The purpose was to brainstorm on ideas taking an overview of the present scenario, gain a clarity of thought and strengthen the base of our understanding. At the meeting, the group decided on broad areas to devise an action plan. At present, NAGAR is in the process of identifying potential locations in Greater Mumbai for a case-study to understand traffic snarls and parking and put forth probable solutions to curb this menace.

NAGAR was one of the associate partners for the conference, 'The Future Of Our Past – Conserving Historic Cities in South Asia', held on November 16-17, 2016 at the Chhatrapati Shivaji Maharaj Vastu Sangrahalaya, organised by the Observer Research Foundation, Mumbai, in collaboration with the Government of Maharashtra and Jindal Steel Works. Ms. Nayana Kathpalia, Trustee – NAGAR, in a panel discussion, spoke about the importance of conservation of public open spaces, and her related experiences, along with the relevance of built and natural heritage, and their value, especially in Mumbai.
